County Waste OK'd

A few hundred people filed into the Appomattox County High School auditorium, the choice location for Tuesday night's Board of Supervisors meeting that included a public hearing for continued discussion on the waste transfer station topic. The end result was that the board voted 4-1 in favor of granting the conditional use permit to County Waste.

Before the vote, almost 50 people rose to the podium. All but a handful spoke with hopes of persuading the board to hear their concerns and act accordingly: to "dump the dump," a phrase printed on many of the shirts worn by those present to protest County Waste.

The discussion centered around County Waste of Southwest Virginia's ap-

The Virginia Lottery announced Friday that Stanley McIvor of Concord claimed a \$4 million lottery top prize.

The first indication McIvor had that something unusual had happened was when his wife, Marilyn, walked out of the store toward their car.

"She was screaming, 'We won! We won!'" McIvor later told Virginia Lottery officials.

It happened at Carson's Mart located at 10060 Village Highway in Concord. He said that as she went in to the store, he gave her
