Fire destroys home in Concord

On Monday evening, Concord Volunteer Fire Department (CVFD) Company 13 and Appomattox Volunteer Fire Department (AVFD) were dispatched for a residential structure fire on Winery Lane in Concord at approximately 8 p.m.

First arriving units found heavy fire showing from the charlie delta corner (the back, right side). Crews immediately made an aggressive interior attack and conducted a primary search.

Crews initially got a good knock on the fire but were quickly forced to evacuate the building due to water supply prob-

Once the water supply was fully established, crews again attempted to control the fire, however the fire had grown at such

a rapid pace, the fire could not be contained.

Crews transitioned into a defensive attack and worked to keep the fire from spreading to a nearby structure.

No was injured and all residents made it safely out of the building.

The cause of the blaze has not benn reported as of press time.

Units on scene from CVFD were: Engine 13-2, Tanker 13-4, Tanker 13-3, Brush 13-7, and Command

AVFD units on scene were Company 10, Company 12, Company 14, Company 15, and Company 17.

Also assisting were the Monelison Fire Department, Pamplin Fire Department and the Concord Rescue Squad.

At Thursday's meeting of the Appomattox County School Board, Dr. Amy Huskin, the director of curriculum, instruction and CTE at Appomattox County Public Schools, presented a video that featured high school students describing how their involvement in specific CTE (Career and Technical Education) courses has assisted them in developing skills that will help them in future careers.

CTE offers hands-on experience in a variety of technical and laborintensive fields. Among the courses featured in the video were commercial graphic design for businesses, auto tech, nursing, agriculture (FFA), child development, CST (Computer System Technology)

Friday, Jan. 28. and culinary arts.

High school CTE students act as tour guides for the eighth-grade visitors, and they are identified by wearing specially made T-shirts. The tour guides show them how their chosen course has helped them grow and learn in their specific area of interest.

Huskin said she

"excited" for the event to return this year after being canceled the previous year because of strict CO-VID-19 regulations that relegated a number of students to virtual learning. She believes that seeing the classrooms in-person is the only way for eighth graders to be fully inspired by what they can see.

"For them to actually get to rotate through all the systems and come over and spend the morning, you can't replicate that; you can't do that on a video," she said.

45 units fight fire

At 12:34 p.m. Sunday, Concord Volunteer Fire Department (Company 13) was dispatched to reports of a brush fire that spread into multiple structures.

According to the Appomattox Traffic and Awareness online news page, the large brush fire was off Archer Creek Road (off Stage Road).

First arriving units advised that approximately two acres were on fire and threatening a structure. While attempting to contain the fire, high winds pushed the fire into nearby structures, the fire department stated.

The call was upgraded to multiple working structure fires. Crews worked on scene for six hours putting the brush, house, shed, and car fires all out.

"Great work from all involved," the fire department stated. "Thank you to the multiple surrounding agencies involved." Appomattox Traffic and

Awareness stated that most surrounding counties assisted, so Lynchburg City covered Concord calls and Pamplin covered Appomattox. There were 45 units on



A & First Responder Club team up for safety

On March 15, the Appomattox Senior FFA and the Appomattox County High School First Responder Club held a joint meeting with the Appomattox Volunteer Fire Department about the importance of farm safety.

There they simulated a tractor rollover.

According to the Department of Labor, tractor rollovers account for 44 percent of all tractor fatalities. The volunteer firefighters and First Responder Club demonstrated members how to safely extricate a mannequin from underneath the tractor.

Afterward, there was a power take off (PTO) shaft injury simulation using a bush hog. A straw scarecrow was drawn into the rotating PTO Shaft.

According to the CDC, about 167 agricultural workers suffer a lost work time injury every day. Five percent of the injuries result in permanent impair-

Each participant was reminded that safety is an important attitude to incorporate into the agricultural lifestyle.

Dodge still with school as teacher

Appomattox County Public Schools (ACPS) has confirmed that Chris Dodge, the athletic director at Appomattox County High School (ACHS), has been reassigned from the position but is still employed by the school

"Mr. Dodge has been reassigned to a teaching position for the 2022-23 school year. I am not able to comment on any

details as it is a personnel matter," said ACPS Superintendent Annette Bennett in an email to the Times Virginian.

The Times Virginian contacted Dodge by email for a statement. He replied, stating he is "unable to comment at this time."

Dodge was hired as ACHS athletic director in 2013. During his tenure, the school has won multiple state athletic team and individual championships in football, softball, baseball, golf and track and field, as well as marching band competitions.

According to a Times Virginian article in 2013, upon being hired as athletic director, Dodge had worked at Brookville High School in Lynchburg as a physics teacher before coming to ACHS. While at Brookville he coached several junior varsity sports including
