## Gov. lifts school mask mandates

The Bedford County School Board voted 4-3 in a special called meeting Thursday to implement the changes to their health and mitigation strategy, which started Monday rather than Feb. 1. This comes after new Virginia Gov.

Glenn Youngkin signed an executive order to make masks optional as of Monday.

Before the vote, District 5 representative Georgia Hairston made a motion to postpone the vote so they could ask all of the Bedford County

## FCBOS hears volunteerism, militia topic

During the Franklin County Board of Supervisors meeting Jan. 18, close to a dozen supporters of the Franklin County Militia voiced their support of a resolution affirming the right of citizens to volunteer. The county currently doesn't recognize the militia.

The board had a brief discussion about volunteerism near the end of the meeting before the public comment portion of the meeting. The militia was not mentioned by name, but Blue Ridge supervisor and vice-chairman Tim Tatum said he supports volunteerism and that he applauds everyone who uses their time to serve the community. He added that volunteering is a Godgiven right to help each other and the community as a whole.

"For that reason, I support this board passing a resolution supporting the rights of our citizens to volunteer to help our community, and that's where I stand," Tatum said as applause broke

Chairman and Boone District supervisor Ronnie Thompson also didn't mention the militia by name but said the county has a tremendous volunteer program through the sheriff's department, public safety, fire & rescue, etc.

## Westlake tower construction can start soon

After months of delay, the Westlake telecommunication tower is the closest it has been to construction after a special use permit was granted to Blue Ridge Towers by the Franklin County Board of Supervisors on Tuesday, Jan. 18.

The Westlake tower will be the last of the eight new towers being built. The eight new towers and four existing tower structures that are being utilized are from a \$4.6 million broadband project. \$2.4 million came from a grant from the Virginia's Telecommunication Grant Initiative by the Virginia Department of Housing and Community Development. The project must be completed by April 15

of this year. The tower, which was originally 195-feet, will now be a 160-feet monopine structure that will have tree branches reach to the upper two-thirds of the pole. It will be located on Parkcrest Drive, less than half a mile from the Booker T. Washington National Monument, and

Other mitigation strategies that were discussed are a 100foot wide buffer on the west side of where the tower will be located and tree planting.

will be just under 12-acres.

# Your call to be a light in this world

Popular entertainment has a way of both reflecting and reinforcing a society's values, as the public, quite literally, buy it because they value it.

By looking at popular entertainment, one can see how American society has changed dramatically with respect to manners and social discourse in a short period of time. The polite society reflected in television shows of the 1950s and early 1960s, think of "Leave it to Beaver," is gone. Those old sitcoms have been replaced today by gaudy reality programs that showcase domestic and social interactions driven by narcissism, factionalism and selfishness. One program reflective

of the whole ugly reality show genre was the show "The Weakest Link." For a short time more than a decade ago, it was quite popular. The presumption that we'd all enjoy watching the host be so mean to the contestants was troubling. The first host, Anne Robinson, it seems, was made for the job. She got to say what the producers apparently

thought all of us would like to say if we were not so inhibited by good manners and common decency. For Anne Robinson, and others, pointing out that someone else is the weakest link, and why they are the weakest link, is telling the truth the way we'd all like to tell it.

I wonder if that's true. I suppose there is a part of all of us that does somehow feel superior, if we can point out the inferiority of others. Yet, for as much as that might be something of a natural inclination in me, or in you, I think that we are made for much better, called to be something very much better. The practice of mercy, as

well as charity, and justice, and humility, is a sign of a true follower of Christ. Simply believing propositions is not enough to make one truly a Christian. What you believe to be true is important, but not singular. Being a faithful member of Christ's church also involves some action. Action with motives aimed at obedience to God, and at treating our neighbors with the wondrous respect due their creation in the very image of Almighty God.

The church father, Justin

Martyr, in his First Apology said this, "When we are together, we remind one another of these things, and help all who suffer want as best we can, and keep together in harmony."

In a world where road rage, and air rage, and all kinds of other rage, have become commonplace. Where bad manners and "in your face" have become the attitudes of the "successful" people, Christians are meant to hold to a different standard. We are citizens of heaven and members of the household of God. We remember and celebrate the fact that you are to be not

the weakest link, but in fact a link to all that is good, and righteous, and holy.

We do not need more spoiled children in the world, demanding their own way and disrespecting one another. We need more women and men who look and act like they are adopted children of God. If you continue to listen to the voice of the Lord, you will have the strength to live as you ought, to live out your call to be a light in this world, to be goodness and love in the flesh, to be holy and godlike, the strong link to God that we all need.

There was a push back against the militia during the public comment portion of the meeting. Glenna Moore said that the unorganized militia's resolution is an attempt to "smokescreen" their intentions to gain permission to train for intimidation as volunteer-

Moore claimed that during a peaceful black lives matter rally, there were two militia members who made themselves standout wearing military-type clothing and branding militaristictype weapons in the presence of unarmed adults and children.

"As a citizen, I felt more secure with the protection of Franklin Sheriff's Office and the Town of Rocky Mount Police Department. At least

they are accountable. What would be the county's liability if my grandchildren had been harmed by a reckless militia that has the stamp of approval from the board of supervisors?" Moore asked.

Larry Moore also spoke out against the militia, saying the only mission of a militia is to overthrow the government. Larry Moore also questioned that if the group wants to help during local emergencies, why don't they volunteer for the rescue squads, fire departments or other local agencies.

Brian Wood, who is the chairman of the militia, said they have some militia members who are in those first responding agencies, but also said beforehand that volunteering in these departments does not exercise or protect Second Amendment rights.

Wood said that militia members serve in different ways throughout the community and they have the right to volunteer for militia service and exercise that right. He also encouraged the board to vote in favor of the resolution and make a statement for their rights.

"It would be nice to know who among our elected public servants would affirm our right to volunteer to do so; the people also deserve to know who among their elected public servants stands in opposition to their Second Amendment rights in a well-regulated militia," Wood said.

He said voting in favor of the resolution does not mean the county is recognizing a militia or authorizing a militia, saying the county doesn't have those powers, but he noted that it affirms their rights to volunteer for service in a militia.

No decision was made at the meeting.

succeed. He launched his second band – the one that lives on today - in March of 1938. The Glenn Miller Orchestra has been a "hit" ever since.

The legendary Glenn Miller was one of the most successful of all dance bandleaders back in the Swing Era of the 1930s and '40s. A matchless string of hit records, the constant impact of radio broadcasts and the drawing power at theatres, hotels and dance pavilion, built and sustained the momentum of popularity.

Glenn disbanded his musical organization in 1942 at the height of its popularity to volunteer for the Army. There, he organized and led the famous Glenn Miller Army Air

On Dec. 15, 1944, Major Miller took off in a single engine plane from Europe to precede his band to France, disappearing over the English Channel, never to be seen again. The army declared him officially dead a year later. With the release of

the major motion movie The Glenn Miller Story featuring Jimmy Stewart and June Allyson in 1954, interest and popular demand led the Miller Estate to authorize the formation of the present Glenn Miller Orchestra. On June 6, 1956, and under the direction of drummer Ray McKinley who had become the unofficial leader of the Army Air Force Band after Glenn's disappearance, the reformed Glenn Miller Orchestra performed its first concert and has been on the road ever since. Other leaders have followed Ray including clarinetists Buddy DeFranco and Peanuts Hucko, trombonists Buddy Morrow, Jimmy Henderson, Larry O'Brien and Gary Tole, and tenor saxophonist Dick Gerhart. Since January 2012, vocalist Nick Hilscher leads the band.

Today, the 18-member ensemble continues to play many of the original Miller arrangements both from the civilian band and the AAFB libraries. Additionally, it also plays some more modern selections arranged and performed in the Miller style and sound.

Just as it was in Glenn's day, the Glenn Miller Orchestra today is still the most sought after big band in the world.

Former Rocky Mount police officer Thomas Robertson is facing upgraded charges related to the U.S. Capitol riot Jan. 6, according to court documents.

documents reveal

in count four that Robertson allegedly carried a large wooden stick into the Capitol, which prosecutors claimed is a "deadly and dangerous weapon." This upgraded the entering and remaining in a restricted building or grounds charge to a felony.

Of the five counts that were

handed down by the grand jury, count two is "Civil Disorder and Aiding and Abetting," a felony.

Documents reveal that Robertson allegedly "committed and attempted to commit an act to obstruct, impede,

# Webber IIving without fear during his final days

## Cancer diagnosis terminal

EastLake Community Church is one of the largest and most recognizable churches in the Smith Mountain Lake area. Of the congregation, one of the more recognizable faces is 83-year old Ken Webber, who has been attending EastLake since it was founded in 2006.

At church events, one might see Webber smiling and holding two of his Nikon D750 cameras. The same goes for Smith Mountain Lake Christian Academy (SMLCA) and Parkway Christian Academy, where Webber is a frequent at athletic events taking live shots during the

games. However, Webber has slowed down recently and hasn't been as present since around September of last year. After a biopsy, Webber was diagnosed in September with pancreatic cancer, which is in stage four, an advanced stage. Webber said it showed a large tumor on his pancreas, and a spot has developed on both of Webber's lungs. He said he didn't feel any symptoms but just lost a good amount of weight, even then he didn't suspect anything was wrong.

# 26 dogs rescued; Goodview resident charged

A Goodview resident was arrested and charged with animal neglect after dozens of dogs were found malnourished, according to the Bedford County Sheriff's Office last week.

On Jan. 25, The Bedford County Sheriff's received a tip from Crime Stoppers and the Bedford Humane Society in reference to possible animal hoarding and cruelty occurring at a residence on the 1500 block of Eagle View Drive in the Goodview area of Bedford County.

Animal Control deputies arrived at the residence to find approximately 26 dogs in and around the residence in poor living conditions and malnourished. Deputies then secured and served a search warrant for the property to recover the animals and get them treated.

With the help of the nonprofit organization "Friends of Bedford County Animal Shelter" and Dr.

Ryan at Riverside Veterinarian Clinic assisting in this investigation, deputies were able to transport all of the animals away from the scene to receive treatment

and be housed. The suspect in this case, Thomas Duggins, 71, of Goodview, was arrested on scene and at this time charged with 10 counts of animal neglect. This is an ongoing investigation, and additional charges may be

sought at the completion. The sheriff's office expressed appreciation to the public for alerting the office to this situation so officers could step in and "help

the helpless." "This large-scale rescue could not have been possible without the assistance of Dr. Ryan at the Riverside Veterinary Clinic and the Friends of Bedford County Animal Shelter," the sheriff's office stated. "This is just the beginning

and interfere with law enforcement officers lawfully engaged in the lawful performance of his/her official duties incident to and during the commission of a civil disorder which in any way and degree obstructed, delayed, and adversely affected commerce and the movement of any article and commodity in commerce and the conduct and performance of any federally protected function and did aid and abet others known and unknown to do the same."

Count four alleges that both Robertson and Jacob Fracker, who is the other former Rocky Mount police officer facing charges related to the Capitol riot, "knowingly and with intent to impede and disrupt the orderly conduct of Government business and official functions, engage in disorderly and disruptive conduct in and within such proximity to, a restricted building and grounds, that is, any posted, cordoned-off, and otherwise restricted area within the United States Capitol and its grounds, where the Vice President was temporarily visiting, when and so that such conduct did in fact impede and disrupt and orderly conduct of Government business and official functions." The counts were filed Jan.

Before the upgraded charges, Robertson was charged with Obstruction of an Official Proceeding; Aiding and Abetting; Entering and Remaining in a Restricted Building; Disorderly and Disruptive Conduct in a Restricted Building; and Violent Entry and Disorderly Conduct in a Capitol Building or Grounds.

The main reason for

that? A group of six freshmen wrestlers, who all placed within the top four for their weight bracket of the VHSL state wrestling tournament. These six freshmen are Colin Martin (36-2), Noah Nininger (38-3), Brady Barns (35-7), Peyton Hatcher (24-11), Macon Ayers (37-9) and Josh Kelly (25-7).

"I remember being little

# **Michael Brown** not guilty

## By reason of insanity

Ex-Marine Michael Alexander Brown has been found not guilty by reason of insanity in connection to the murder of Rodney Wilfred Brown, described as Michael Brown's stepfather.

Michael Brown also was found not guilty on other charges that included use of a firearm in commission of a felony (two counts), armed breaking and entering of an occupied house, firearm larceny, and stealing Rodney Brown's credit card. Michael Brown did

plead no contest to a felony

of breaking and entering with intent to commit larceny. He was found

M. Brown

guilty and sentenced to 10-years, but judge Stacey Moreau suspended all of it. He will now spend time in a mental hospital and gave up his right to own a firearm.

Near the end of the bench trial, the judge said that Michael Brown was not aware of his actions

## **BCSC** hears from Dist. 7 candidates

The Bedford County School Board held a public hearing Monday that gave the finalists for the interim District 7 spot to a chance to make their case for the seat, which was originally held by Martin Leamy, who resigned last month. The public hearing was held at Liberty High School.

The three finalists for the interim appointee position are Christopher Daniels, Raymond Smith and Cherie Whitehurst.

Daniels went first and spoke to the board via Zoom due to him being on a business trip. Daniels organized his six minutes

into three sections: Life, Liberty and the pursuit of Happiness, a phrase from the United States Declaration of Independence.

For life, Daniels said he has been fortunate to raise his two twin boys in Bedford County the past four years and added his family attended schools such as Jefferson Forest High School.

Daniels explained he is a product of 12 schools and how he has been a private business owner for 23 years. Daniels told the board he wants to serve and be a voice for the parents, students, guardians and teachers.

due to mental health issues. He was diagnosed with dissociative amnesia. His defense attorney, Deborah Caldwell-Bono, the judge made the right de-

She later said that after looking at everything she saw and heard, she thought that the ruling would be in Michael Brown's favor. She said he is someone who needs help, not to be locked

"He's grateful for the opportunity to go there and get the help that he needs so that hopefully he can return to society rather soon and continue to be a good, produc-

tive citizen," she said. During the motion hearing, two psychologists reportedly testified as witnesses of Michael Brown's mental health and believed that he met state requirements for a defense of insanity.

Michael Brown had allegedly experienced blackouts, depression and signs of dissociative disorder, as well as trauma for physical abuse at the hands of Rodney Brown.

The prosecutors argued that Michael Brown was aware of his intentions with the amount of weapons that was found in his RV as well as writings he wrote about the murder and his past of lying during his time in the Marines.

Commonwealth Attorney A.J. Dudley, who has been practicing law for 22 years, said this particular case is unique.

"Opposing counsel has said the same thing. Her honor said the same thing to us. This is an extremely unique case, unique facts, circumstances," unique Dudley said. When asked if he felt

justice was served, Dudley said, "That's the way the system is designed to work."

"As I alluded to before, we feel that we presented the court with a full amount of evidence. There's nothing that we wanted to present to the court that we did not, and in that regard, we respect the process and the judge's ruling," he said.
