Jenny Morris, a former administrative assistant at South Boston Speedway who brings with her an extensive background in auto racing, has been named Senior Director, Guest Services and Administration at South Boston Speedway.

The South Boston native will begin her duties with the speedway on Nov. 1.

"I'm thrilled Nick (Pocono Raceway CEO and South Boston Speedway CEO Nick Igdalsky) approached me about this position," Morris said. "I have always thought of South Boston Speedway as home ever since my time working with Cathy Rice and I'm excited to be returning to the track. I have truly missed the racing community, and I look forward to being a part of it again."

This will be Morris's second stint at South Boston Speedway. She served as administrative assistant at South Boston Speedway from 2007 through 2017. During that span she assisted in planning and organizing events, carried out many of the guest services functions around the speedway on race days, provided event information to race-day staff, and developed and maintained the track's presence on social media.

In addition to those duties, Morris served as Director, Timing and Scoring at South Boston Speedway from 2009 through 2017. She also handled timing and scoring for PASS Series events at South Boston Speedway, Orange County Speedway and Caraway Speedway and handled timing and scoring for major regional events that included the Thanksgiving Classic at Southern National

Motorsports Park, the Hampton Heat 200 at Larry King Law's Langley Speedway, and the Valley Star Credit Union 300 at Martinsville Speedway.

Morris worked for NASCAR as a timing and scoring official from 2016 through 2018. In that role she worked directly with race directors in the NASCAR Craftsman Truck Series, the NASCAR Xfinity Series, the NASCAR Cup Series, and other NASCAR touring series in race control. She also operated the start/finish line photo finish camera on pit road.

Morris, who holds a bachelor's degree in communication studies from Longwood University, comes to South Boston Speedway after having served four years as payroll administrator at WS Construction in Providence, North Carolina.

"Jenny's previous experience at South Boston Speedway and her extensive background in racing make her such an asset," said Incoming South Boston Speedway General Manager Brandon Brown. "She has a great understanding of what it takes to make this venue a success, and I can't wait to work with her. We look forward to her joining the South Boston Speedway team."

As Sheriff, I will be a working Sheriff not a desk Sheriff. While serving equal and fair justice for the citizens of Charlotte County.

#### SCHOOLS:

Ensuring teachers of their safety while also ensuring parents of their children's safety; by Deputies doing daily walks throughout the schools, more visibility during after school activities (which is lacking at this moment), more drug sweeps at the Middle and High School.

#### RESPONSE TIME:

Introducing zone areas, the response time will be cut down tremendously. 3 zone areas, consisting of North Zone (1 Deputy), Central zone (2 Deputies), and South Zone (1 Deputy). Deputies will be assigned to a zone area to ensure the county is covered and response time is reduced. Additionally, Zone 2 deputies that are not on a call will back up Zone 1 and Zone 3, if needed. Also, there will be coverage in area stores when doing late night closings for better security, while also doing business checks after 11 P.M. With verifiable checks of time. Making sure that all calls for service are responded to promptly fair and equally. There will be 24 hour coverage in all zone areas.

#### COMMUNITY POLICING:

Better community policing while patrolling will be implemented. Such as going into establishments and meeting the owners or asking if they have any issues or concerns. The citizens and business owners should be heard.

#### FOLLOWING UP TIME FOR VICTIMS OF A CRIME:

Follow up time will be established. A person that has been victimized should be explained the next steps in the process while ensuring timely updates. With a 3-5-day follow-up, you will be ensured that fair and equal justice will be served.

#### PROACTIVE DRUG ENFORCEMENT:

Proactive drug enforcement will be established and taken seriously. By implementing more proactive patrols in verified drug areas or high crimes areas. Drugs, Money, and Guns are transported by vehicles. With the help of the Virginia State Police, we do saturation patrols on crackdowns. My promise to the citizens of Charlotte County is not to let the county to be a haven for drug dealing and manufacturing of drugs. We do have a drug problem in Charlotte County and our kids need to feel that they will be safe. Will implement a Drug Interdiction Team: More transparency within the Sheriff's Office.

#### TRAINING FOR JAIL STAFF:

We will start the process of getting the jail staff road certified, if an emergency arises the jail staff can be on call to help assist them.

I will be a Sheriff for the people with an open line of communication.

Being a current Deputy of Halifax County, I have seen this philosophy work firsthand and it is successful.
