Road reopens after sinkhole filled

All of 4th Street in Victoria is open again for traffic, after work crews fixed a sinkhole that developed last week.

Victoria Town Manager Rodney Newton said the town's public works staff have

been repairing the problem, which developed on 4th Street between Washington and Main Streets on Tuesday, Oct. 17. The street was closed to through traffic, but left open for residents to get to their homes.

"The investigation revealed a sewer line collapse around

a lateral connection from a residence on that street," Newton said. "The crews began excavating to make repairs and discovered a deteriorated sewer main."

Newton said that after the public works crew got to the

sewer line, they made the decision to replace it due to the existing pipe's condition.

About 400 feet of 8-inch line has been replaced to stop the leak, so the sink hole could be back-filled to resolve the issue, he explained.

Google Maps shows the section of 4th Street is a resi-

dential area with about a half dozen homes, just two blocks from downtown.

As of Monday afternoon, Newton said all residents on the affected street have been connected to the new sewer main.

Miyares asks sheriffs to donate

Virginia Attorney General Jason Miyares sent a letter out on Tuesday, Oct. 17, one that went to Lunenburg County Sheriff Arthur Townsend, along with every other sheriff in Virginia.

He just included one request, asking all 123 sheriffs to consider donating their expired or excess law enforcement gear to the Office of the Attorney General. Then in turn, Miyares explained, the AG's office would send it all to the Israeli military.

"I am shocked and grieved by the senseless terrorist attacks on Israel by the Hamas terrorist organization," Miyares wrote. "The loss of innocent life and disregard for human rights is painfully tragic to see."

Miyares said he's seen multiple groups offering support or humanitarian relief. What he wanted to do was something along the same lines, but given to a different group.

"My office is coordinating efforts to collect surplus body nor, protective gear, and tactical equipment from local law enforcement departments that want to help the Israel Defense Forces fight terrorism in Israel and Palestine," Miyares said in the letter. "If you have excess law enforcement protective

Three counties. One enterprise zone. No answers.

It's something you don't exactly see every day. Lunenburg, Charlotte and Prince Edward counties are connected to each other through an enterprise zone, one that exists on each of their respective borders. But the problem is that the enterprise zone, where specific incentives and other deals can be made for economic development, is going away unless something changes in the next 12 months.

The counties have until the end of 2024 to get a five-year extension on the zone. But to

date, no state lawmaker has been willing to carry that bill.

County officials agree the enterprise zone makes the region more appealing to prospective business and industry.

"The Lunenburg Board is aware of the possibility of expiration of the zone and supports its continuation," Lunenburg County Administrator Tracy Gee said Monday.

Gee's counterparts in Charlotte and Prince Edward agree.

"It's been a great opportunity to be collaborative and really have a regional approach to economic development," Prince Edward Director of

equipment, my office will collect them and ship it to the Israel Defense Forces."

IS THAT LEGAL?

And understandably, that brought up some questions and concerns. Questions from Virginia residents who asked if it was legal for an attorney general to do this and concern from people who wondered if excess supplies from some of the wealthier counties in Virginia couldn't be better used in places like Lunenburg, where departments don't have as

Miyares said he recognized some departments couldn't contribute.

"While I'm aware that some police departments are stretched for resources, there are many departments that have expired equipment (that is) required to be donated or discarded," Miyares wrote. "During

my trip to Israel earlier this year, I met women and men who serve in the Israel Defense Forces who are willing to give their lives to maintain peace in this region of the world. They are committed to democracy and the public safety of their land, and I am proud to stand with them during this difficult time."

As for the question if it is legal, the answer appears to be yes. *The Dispatch* reached out to three different law schools and while none of the professors would go on the record, those we talked to said they saw no legal problem with the concept.

Consumer fraud triples

The numbers are in. The Federal Trade Commission released its annual compendium of fraud reports from last year, and the news is shocking. Over the past three years, reported losses to consumer fraud has tripled, coming in at a reported \$5.9 billion in 2021.

Nearly six million US consumers reported a scam last year and the median loss was \$500. But the FTC can only tell us about fraud that was reported – we know the losses and number

of victims is far higher. Many factors contribute to under-reporting, including the abundant shame victims feel. AARP officials argue this has to change, starting with how we talk about fraud victims. That means changing the current narrative that suggests it's the victim's fault she was duped, he was swindled, they fell for it. AARP officials urge people to focus instead on the crime and the criminal. That means easing the emotional burden while making it clear that fraud is a crime.



is also a member of the track team, sideline and



NOTICE TO THE PUBLIC OF AN APPLICATION BY COLUMBIA GAS OF VIRGINIA, INC., FOR APPROVAL OF A NEW RATE SCHEDULE RNG AND TARIFF PURSUANT TO § 56-236 OF THE CODE OF VIRGINIA CASE NO. PUR-2023-00159

On September 7, 2023, Columbia Gas of Virginia, Inc. ("CVA" or "Company") filed an application ("Application") pursuant to § 56-236 of the Code of Virginia. CVA's Application seeks approval of its proposed Rate Schedule RNG: Renewable Natural Gas Receipt Service ("Rate Schedule RNG"). Specifically, the Company proposes Rate Schedule RNG to allow renewable natural gas ("RNG") producers ("RNG Producers") to interconnect with CVA's distribution system and deliver RNG into CVA's system, and allow CVA to recover the costs associated with such interconnection(s) from RNG Producers. The Company states the rate for Rate Schedule RNG service will be unique to each of the RNG Producers who enter into an agreement for service under the proposed tariff. CVA states that the rate will be based upon the cost of service associated to the Company's facilities required to

In support of its Application, the Company states that it has been approached by potential RNG Producers who have expressed an interest in connecting their facilities to CVA's distribution system and delivering RNG to the Company. The Company asserts that the proposed Rate Schedule RNG enables CVA to recover the costs associated with such interconnections from the RNG Producers, and not from CVA's general body of customers. The Application states that service under Rate Schedule RNG will be available to RNG Producers in CVA's certificated territory who enter into a Facilities Interconnect Agreement with CVA for an interconnection to deliver RNG to CVA for CVA's system supply. The Facilities Interconnect Agreement will specify the terms and conditions of the interconnection of the RNG Producer's facilities to the Company's facilities including the cost thereof.

CVA requests that the Commission find Rate Schedule RNG to be in the public interest because, according to the Company, it allows RNG Producers to interconnect with CVA's system and thus the ability to provide RNG, a low to zero carbon fuel, to CVA's customers. CVA states that the use of RNG will reduce the carbon emissions of CVA's customers. The Company further states that RNG interconnection service also provides an opportunity for further development and investment in RNG production with its related environmental and economic benefits. In addition, the Company notes that it has the potential to provide additional supply to CVA.

Further details are set forth in the Company's Application and supporting materials, and interested persons are encouraged to review these documents.

TAKE NOTICE that the Commission may adopt rates and terms and conditions that differ from those appearing in the Company's Application and supporting documents.

The Commission entered an Order for Notice and Comment that, among other things, directed the Company to provide notice to the public and provided interested persons an opportunity to comment on the Company's Application.

To promote administrative efficiency and timely service of filings upon participants, the Commission has directed the electronic filing of testimony and pleadings, unless they contain confidential information, and required electronic service on parties and Staff in this proceeding. Please refer to the Commission's Order for Notice and Comment for further instructions concerning Confidential or Extraordinarily Sensitive Information.

Those unable, as a practical matter, to file a notice of participation electronically may file such notice by U.S. mail to the Clerk of the Commission at the

address listed above. Such notice of participation shall include the email addresses of such parties or their counsel. A copy of the notice of participation also must also be sent to counsel for the Company. Pursuant to 5 VAC 5-20-80 B, Participation as a respondent, of the Commission's Rules of Practice and Procedure ("Rules of Practice"), any notice of participation shall set forth: (i) a precise statement of the interest of the respondent; (ii) a statement of the specific action sought to the extent then known; and (iii) the factual and legal basis for the action. Any organization, corporation, or government body participating as a respondent must be represented by counsel as required by 5 VAC 5-20-30, *Counsel*, of the Rules of Practice. All fillings shall refer to Case No. PUR-2023-00159.

On or before December 13, 2023, any interested person may request that the Commission convene a hearing in this matter by filing a request for hearing electronically via scc.virginia.gov/clk/efiling. Those unable, as a practical matter, to file electronically may file a request for hearing by U.S. mail to the Clerk of the Commission at the address listed above. Such request for hearing shall include the email addresses of such parties or their counsel, if available. A copy of the request for hearing also must also be sent to counsel for the Company. Requests for a hearing shall include: (i) a precise statement of the filing party's interest in the proceeding; (ii) a statement of the specific action sought to the extent then known; (iii) a statement of the legal basis for such action; and (iv) a precise statement why a hearing should be conducted in this matter. All filings shall refer to Case No.

Any documents filed in paper form with the Office of the Clerk of the Commission in this docket may use both sides of the paper. In all other respects, except as modified by the Commission's Order for Notice and Comment, all filings shall comply fully with the requirements of 5 VAC 5-20-150, Copies and format, of the Rules of Practice.
